## ACCA EXAM PAPERS

ACCA exams are divided into two levels;  
Fundamental Level and Strategic Professional Level

13 Papers in total - 11 compulsory papers - 2 optional

### PAPERS:

- Exams held 4 times in a year in March, June, Sep and December.
- Exams for BT, MA, FA and LW open throughout the year
- Any number of attempts permitted
- Maximum 4 papers at a time, in a year totally 8 papers can be attempted / passed.
- Course can be completed in two to three years (based on number of papers exempted).
- No Compulsory/Articleship - 3 years' experience required, which can be obtained before, during or after exams.
